



4 Accounting Year:

The accounting year of the Trust shall end on 31<sup>st</sup> March of every year or as may be amended by the trustee time-to-time.

5 Objectives of the trust:

I In the field Human resource and Development

- (a) To established, develop, maintain school Urdu, Arabic, Hindi, English Medium School textile, Charitable Ambulance, I.T.I. under N.C.V.T. course, colleges, para-Medical College, Engineering college, Pharmacy college, Dental College, Laboratories skill development center, competition Preparation Centres, Yoga and spiritual centres, sports training centres, vocational and technical training centres, Research and other institutions for the development and advancement of education and diffusion of knowledge among the public in general.
- (b) To establish, maintain and run studentship, scholarship and aware programme and aware programme and render other kind of aid to students including supply of study material.
- (c) To organize programme for the promotions of the pre-primary education, non-formal education, computer and information technologies, leadership development techno-entrepreneurship development education infrastructure research and development socio-scientific research, management.
- (d) To start, established run takes over or managed and Urdu, Hindi, English medium school with an object to provide sound pre-primary, primary, secondary, senior secondary, higher education to children by seeking reorganization and affiliation from the educational department and concerned Govt. authorities.

II In the field of Health and family Welfare.

- (a) To undertake, establish, assist, organize or conduct the programme of research management and infrastructure development in the field of health and family welfare.
- (b) To establish, organize, run or maintain Hospital Nursing Home care and care centers, medical education and research centres in state of art.
- (c) To undertake organize, establish or run the medical education centres, college and research centre.
- (d) To undertake awareness, prevention, surveillance, screening management health systems and research programme on Maternal and child survival communicable diseases like Malaria, Hepatitis, Leprosy, Meningitis, HIV, AIDS STD, tb, Dengue, non-communicable disease like Cancer, Heart and population control etc.
- (e) To establish and insurance run drug De-addition centre undertake rehabilitation programme for drug abuse. Also organize Awareness programme for the control of drug minable and abuse.

III In the field of agriculture and allied industries Development

- (a) To conduct and undertake the research of technologies advancement, productivity enhancement, cost effectiveness technologies and methodologies in the field agriculture allied industries, cottage in industries veterinary and co-operations.
- (b) To conduct plantation, including medicinal plant, edible oils, and non-edible oils cultivation, bio-diesel plant with the activity of oil extraction from seeds and plant, refining the extracted oil and making of the oil and oil products.
- (c) To conduct awareness and exposition, programme of appropriate and low-cost technologies agriculture.

- (d) Conduct the programmes to ensure nutrition security safe food processing and standardization.
- (e) Conduct the intensive research in the field of fisheries, aquaculture, poultry, darying livestock, sheep and goat, horticulture, floriculture aromatic and medicinal plants, fruits, hybrid vegetables, mushroom, etc. and the benefits of research.
- (f) To carryout study, search and development activities for water management, irrigation, fertilizer, farm mechanism, biotechnology, integrated pest management method.
- (g) To make the market-mechanism and even indulge in marketing activities for giving most favorable and optimum value to the farmers. To develop the infrastructure for the easy and safe delivery of agro products also establish and run financial institution for the benefits of agriculture and allied industries related people.

#### IV In the Field of Rural Development.

- (a) To promote education, training and research programmes in Rural Management and generate a Human Resources to settle the needs of people in rural areas
- (b) To organize, conduct, sponsor, the intensive programme on Rural house, Rural finance, Marketing mechanism infrastructure development, artisan promotion and development, cottage and small scale industries development, Co-operative and cooperation integrated wasteland development technology development extension and training programme, Investment promotion schemes for the promotion of rural infrastructure, water land and water management and unutilized resources development programmes welfare and strengthening programme for marginal and underprivileged farmers, promotion of cost effective technologies rural sanitation including low cost latrines.
- (c) To work Associate and/or act as implementing agency in Swarn Jayanti Gram Swarozgar Yojna, Samgra Awas Yojna and other development programme run by Government Agencies.

- (a) To carry out all the programmes science and technology and communication information technology for popularization use and inculcation of scientific temper among the people. Also ensure the use of technologies in the field of rural development and appropriate technology rural technology environment and ecology non-conventional energy, formal education computer education etc.
- (b) To organize the programme and set-up infrastructure for the creation of technology entrepreneurship through structured training programmes and other facilitating mechanism.

### 1. RULES REGULATION OF JAY RESHMI EDUCATION AND SOCIAL TRUST

#### 1. Definitions: -

- (a) Society means: - JAY RESHMI EDUCATION AND SOCIAL TRUST
- (b) Committee means: - The Managing Committee of the society.
- (c) Officer bearer means: - President, Secretary & another elected/ nominated trustee

- (d) Body means: - The General body of the Society.  
Need to add a clause for inclusion and expulsion by Patrons.

### MEMBERSHIP

- (i) Any Indian Citizen, not below the 18 years of age and who are interested in preservation, promotion and popularization and follow the Rules & Regulations of the society can become member of the trust by paying lifetime registration fee of INR 501/- followed by annual fee of INR 101/- subject to approval by committee of the trust.
- (ii) A person desirous of joining the trust shall apply in writing on a prescribed form to the Secretary of the Managing Committee and shall be rejected or accept the same without assigning any reason thereof.
- (iii) A person whose membership was terminated due to sub- clause (iii) of clause 2 of termination of membership may become of the member again if he assured the trust that he will follow the rules and regulation of the trust strictly in future.

### 2. Termination of Membership

- (a) Resign or die or become unsound of mind.
- (b) By a competent court sentence to imprisonment for any offence involving moral turpitude by any court of land or abroad.
- (c) If Managing Committee found from any member engaged / indulge in activities which may tarnish the image on reputation of the trust.
- (d) If the member in default in payment of monthly subscription for consecutive periods exceeding three months.

### 3. Managing Committee: -

- (a) There shall be a Managing Committee consisting of 3 members including office bearers to be elected at the annual General body meeting of the society.
- (b) The members of Managing Committee shall hold office for a period of five years.
- (c) Any casual Vacancy of the committee may be filled up by the members of the Managing Committee for the remaining period of the office so.
- (d) The outgoing members of the committee shall be eligible for re-election.

### 4. Power & Functions of the Managing Committee: -

- (a) The Managing Committee shall be solely responsible for the management of all the affairs of the society and it shall have necessary power for executing decision of the general body and managing the affairs of the society in all respect.
- (b) To appoint, transfer, and retire, the personnel of the employees.
- (c) To alienate, sell, lease mortgage, pledge, hypothecate, done to the property whether movable or immovable.
- (d) To implement programmes for the execution of the objectives and allied activities of the workers of the society.
- (e) To raise money by way of subscriptions, donations, grants and loan etc.
- (f) To incur necessary expenditure.
- (g) To consider application for membership.
- (h) To do all such lawful acts and things as identical and conducive to the attainment of the objects of the society.

## 5. Duties & Power of office bearers:-

- (a) He will preside over all the meeting of the Managing Committee and the General body of the society. In the absence of the President, the members present at the meeting shall elect a President from among themselves and such President shall exercise all such powers.
- (b) He will have a casting vote which he will exercise only when there is a tie in a meeting.
- (c) He will guide, direct and supervise all the activities.
- (d) He will look after day-to-day management of office of the society and shall help President to discharge of his duties.
- (e) He will look after any work, if any specially delegated to him by the Managing Committee or the general body and shall be responsible for that work.
- (f) He will convene whenever necessary meeting of the society and of any committee which may be necessary to be called.
- (g) He will keep proper minute or the proceedings of the meeting of the society and will do everything to give effect to the resolutions passed by General body/Managing Committee meeting of Act.
- (h) He will make all correspondences on behalf of the society and keep all records.
- (i) He will submit annual progress reports and audited statement of accounts of the society before the general body meeting.

## TREASURER: -

- \*S/He will receive loans, grants, funds, donations and subscription on behalf of the society.
- \*S/He will keep all records to receive all the vouchers.

## 6. Power & Functions of the General body:-


- (a) The annual General body meeting of the society shall be held every year within three months of the close of the financial year.
- (b) To elect office bearers and members of the Managing Committee.
- (c) To pass the audited statement of accounts and to appoint the auditor for the ensuring year.
- (d) To transact such other matter which may be brought before the meeting by the Managing Committee.

## 7. Meeting: -

- (a) The Managing Committee may meet transaction matter whenever they like to meet but not less than once in every three months.
- (b) The emergency meeting of the Managing Committee may be called by the president or the Secretary by giving only 24 hours' notice to the members of the committee.
- (c) Special general meeting of the society may be called by the President of the Secretary by giving not less than fifteen days' notice in writhing to the members.

**8. Notice: -**

- (a) Notice of every meeting standing the general particulars of all matters to be transacted at such meeting shall be delivered or sent by post to each member.
- (b) 15 clear days' notice specifying, the place, date, time, and nature of matter shall given to the members by post or by hand deliver.
- (c) In case of emergent meeting the same can be convened by giving a notice of 24 hours only.

**9. Quorum: -**

1/3<sup>rd</sup> members present and entitled to vote shall form a quorum at any meeting. If at an extra ordinary meeting there is no quorum within half an hour the meeting shall stand dissolved. If at any Annual general body meeting there is no quorum within half an hour for the time fixed the meeting shall be adjourned and no quorum will be necessary for an adjourned meeting.

**10. Source of Income: -**

- (a) Fees and monthly subscription.
- (b) By donations.
- (c) By Govt. aid.
- (d) Grant and Aid from any other legal sources.
- (e) By Cultural programme and Exhibitions.

**11. Bank Operation: -**

The Bank account of the Society shall be kept in the name of the society in any Scheduled Bank or post office and shall be operated by Secretary will be necessary for operation of the account.

**12. Audit: -**

The Accounts of the society shall be audited by an auditor appointed by the general body. Inspector General of Registration, Bihar on his discretion any time may get audited the society by recognized chartered accountant and the fee for the same will be borne by the society.

**13. Inspection of Registers: -**

All registers will be kept in the registered office. Any member may inspect these registers with the prior permission of the president of Secretary.

**14. Amendments: -**

Any additions, alterations, or omission in the objects and Rules & Regulations of the society shall be effected by resolution of the society shall be effected by resolution of the society by 3/5<sup>th</sup> members of the General body at a special general body meeting of the society.

**15. Legal Proceeding: -**

The Society may sue or be sued in the name of the Secretary.

## 16. Dissolution:-

- The Society may be dissolved by 3/5<sup>th</sup> members of general body present and voting in its meeting specially convened for this purpose.
- Before dissolution of the society, the state Government consent will be obtained, under section 13 of the Society Registration Act 21, 1860.
- If after dissolution there remains any property moveable or immovable after satisfaction of all debts and liabilities. The property so left shall be paid to or distributed among the members of the society But shall be given to some other society or to the Govt. to be determined by the votes of not less than 3/5<sup>th</sup> of the members present in person at the time of dissolution.
